Notice Periods:

Wellington Electricity requires the following minimum notice of high load application:

- Loads below 5.4metres – 2 full working days notice
- Loads 5.4meters and over, and below 6metres – 5 full working days notice
- Loads 6metres and above – 10 full working days notice

Costs:

- Loads of 5.5metres and over may attract escort and other network related charges (eg line drops). An estimate of these costs will be sent to you within the above notice periods. Granting of the permit is conditional on written acceptance of these charges.
